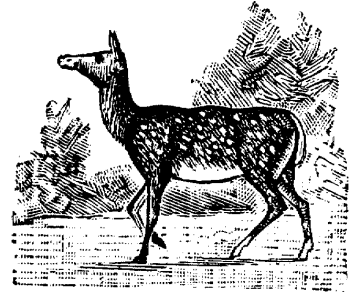

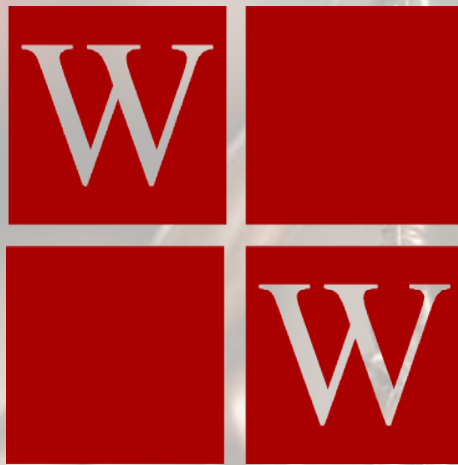

President's Corner



Happy Birthday, America! Two hundred and fifty years sounds like a long time, yet we are still younger than many nations. Our earliest settlers came seeking religious freedom, and for the most part, we still enjoy that blessing today. Most Americans believe in some form of God, and our Constitution — especially the First Amendment

— protects our right to practice our faith as we see fit. Still, it saddens me that even now, hatred and suspicion of different cultures and customs persist.

My own family's story is woven into that larger American tapestry. My grandparents came through Ellis Island from Italy on a ship called *The Americas*. My grandmother, Josephine Rowe — "Lady Bow" to the family — married my grandfather, Biago Olivito, through a family arrangement when she was just fourteen. I remember my cousins and me giving her a little too much wine and asking about her wedding night. She laughed and said she ran around the house trying to get away from him. Well, he must have caught her, because they went on to have fourteen children and a long, loving marriage.

My grandparents were fiercely proud to be Americans. They refused to speak Italian in the home — except when they were fighting, which is how we learned all the good swear words. My grandfather faced real prejudice as a hardworking Italian immigrant. The coal mine only five miles away wouldn't hire him because of his ethnicity, so he walked ten miles to another coal operation. He eventually died from black lung disease from all the years he worked in the mines. Yet he built a beautiful life: stone walls crafted by hand, grapevines for homemade wine in a cellar we were convinced was haunted, and a vegetable garden that stretched the length of his property.

My grandmother was just as remarkable. She canned vegetables for the winter from her garden, baked homemade bread every day, cooked for the local priests and nuns, and worked various jobs (she was an excellent seamstress) — all while raising fourteen children. She couldn't read or write English until later in life, but she cooked by instinct: "two handfuls of this and a dash of that." I still cook that way, and my son still complains that nothing I make ever tastes the same way twice.

What I admired most about my grandparents was their acceptance of others. They welcomed a gay grandson without hesitation, embraced a Jewish son-in-law, celebrated a grandchild who married a Black woman and even accepted me when I left the Catholic faith to become an evangelical Christian. With sixty grandchildren, Sundays at their house were a joyful kind of chaos (thankfully we weren't all there at the same time)— most of us running through

the halls while my uncles' smoked cigars in the library or played poker in the solarium, and my aunts gathered in the large kitchen around an oversized stove, cooking, serving, and trying to keep us kids from getting underfoot. And no, the family was not in unison on politics. They were mostly Republican, though some of us strayed, which made for loud, ruckus arguments that somehow always ended with someone passing the meatballs. Even when they disagreed, there was respect — a kind of spirited debate without the bitterness or division we see today. I tried to hide my liberal leanings and I remember one Thanksgiving when they named the turkey Bill in a derogatory manner. Of course, my son had to pipe up that I voted for Clinton. Everyone stopped eating and stared at me. I wanted to crawl under the table and later ended up lecturing my son on keeping my business private. With that said I eventually learned to stand up for what I believed and knew my family still loved and accepted who I was. People could argue without becoming enemies, and compromise wasn't a dirty word. They all loved Kennedy simply because he was the first Catholic president. Maybe my grandparents' own experiences with discrimination softened their hearts. Whatever the reason, it taught me a lesson I've carried throughout my life: America is strongest when we open our arms, not close our doors.

Our country has made painful mistakes — from breaking treaties with Native Americans, to the horrors of slavery that divided our nation and caused brothers to fight brothers. We looked away from what was happening in Germany and turned away Jewish refugees. We interned Japanese Americans during World War II, even as many of them served bravely in our military. And we still haven't fully learned the lessons of the past. Immigrants — even legal immigrants — continue to face suspicion and unjust treatment. Members of the LGBTQ community are still fighting for rights and dignity that should never be in question. It's why the quiet acceptance my grandparents showed feels so powerful to me now — a reminder that ordinary people can choose kindness even when the world does not. We cannot change the past, but we can learn from it.

As we mark this 250th year, I hope we each take a moment to appreciate not only where our country has been, but where we have the power to guide it next. One of the greatest gifts of this country is our freedom of speech — the ability to speak up, disagree, question, and challenge without fear. The lessons my grandparents passed down — kindness, acceptance, hard work, and faith — are the same values that can carry America forward. We may not be able to solve every national issue, but we can choose to create a community that reflects the very best of who we are. If we do that, then we honor our past, strengthen our present, and help shape a future worthy of the next generation.

3.) Fawn Lakes Condominium A, Section 2, Bylaws, Book 4012, in part from Page 835: "(F) Unit owner's obligation. Each unit owner has the obligation to purchase public liability insurance to protect himself from claims due to accidents within his unit, and shall purchase casualty insurance on the contents within said unit..."

4.) Fawn Lakes Condominium A, Section 2 Rules and Regulations (in part):

"# 2. Alterations, replacements, additions, modification or changes to the common elements or to any outside or exterior of any unit are prohibited by the Master Deed of Condominium A, Section 2."

"# 16. Vehicles, trailers, boats, etc. may not be parked or stored on the common elements."

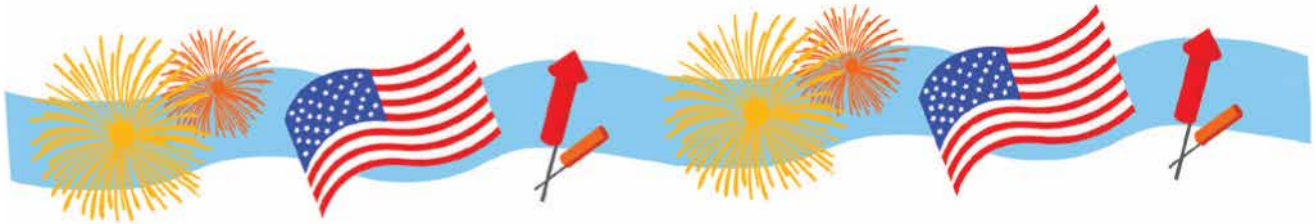

Pool Rules for 2026

1. There is no entrance to pool without a pool badge. Wristbands for additional guests may be purchased for \$2.00
2. Guests are not allowed without the resident. All members and guests must sign in at the pool monitor station.
3. The pool will be open Memorial Day weekend until the week after Labor Day at the discretion of the Pool Director.
4. Pool hours will be 10:00am- 6:00pm. Friday and Saturday the pool will be open 10:00am to 8:00pm. If no one is using the pool, or a monitor is not available, the pool will be closed at our discretion.
5. You must shower each time you enter the pool, especially after applying sun screen.
6. Bathing suits and swim trunks only. No street clothes allowed in the pool.
7. Children are permitted in the pool as long as they are accompanied by a resident.
8. If a child is not potty trained, a swim diaper is mandatory.
9. Children who cannot swim, must stay in the shallow end and not proceed past the rope. They must be accompanied by an adult who is responsible for their supervision and safety.
10. Small pool toys are allowed as long as they do not interfere with others.
11. Diving, running and running jumps into water are prohibited.
12. No glass of any kind is allowed inside the pool area.
13. No smoking, vaping or chewing tobacco is allowed inside the gated area of the pool.
14. Pool safety equipment (painted red triangle on both sides of pool), must remain accessible at all times.
15. Long hair must be tied back.
16. Pool director, pool manager, and pool monitors are not lifeguards. You are responsible for you, your children, and your guest's safety.
17. No one is allowed in pump house except the pool director and pool manager.
18. Everyone who works at the pool are VOLUNTEERS. Rude behavior or arguments with staff will not be tolerated. Check your attitude at the door.

FAWN LAKES CODE OF CONDUCT

We ask all residents of Fawn Lakes to make our community a welcoming and respectful place to live. As such, we expect our residents and their guests to treat other with respect and to abide by the rules in our Code of Conduct at all times.

If a resident experiences or witnesses unacceptable behavior, it should be brought to the attention of a Fawn Lake's officer or Director responsible for handling that issue. If any unacceptable behavior occurs in the pool area or at an event in the clubhouse, it should be reported to the person in charge. Residents are totally responsible for the behavior of their guests.

PROHIBITED ACTIONS:

1. Verbal abuse including insults, derogatory name calling and foul language
2. Aggressive or threatening behavior
3. Hostile touching or physical contact
4. Sexual harassment
5. Defacing, damaging or destroying any condo property or the property of other residents
6. Non-compliance with rules posted in the pool area, clubhouse and common grounds

If a resident is asked to stop displaying inappropriate behavior, immediate compliance will be expected.

CONSEQUENCES:

1. 911 will be called if behavior is deemed to be dangerous to others or to the person exhibiting the dangerous behavior or refusal to leave the area at the time an event is finished.
2. Written warning will be given to the offender by the Board of Directors, for the **first** offense.
3. A **second** offense within a **six-month** period of time will result in a **three-month** loss of privileges to the clubhouse pool, or area where the offense has occurred. A meeting with the community board will be required before privileges are restored.
4. No refunds will be given if a resident or their guest is removed from an event due to non-compliance with Code of Conduct Rules.

Fawn Lakes is a volunteer community where residents give hours of time to maintain services, lower costs, and to provide a safe environment for fellow residents. Please help us continue this tradition.

Sunrise And Sunset

Sunrise is getting later in the morning this time of year, so it's a great time to get our sunrise shots.

It is important to use the rule of thirds. Try not to put the sun in the middle of the frame. Place it toward the side. Having something in the foreground will strengthen your image, especially if it is on the opposite side from the sun.

If you want a silky look to the water, use a tripod and a long exposure. Sunrise images are much better with some clouds to reflect the sun's colors.

Check the monitor on the back of your camera to make certain the

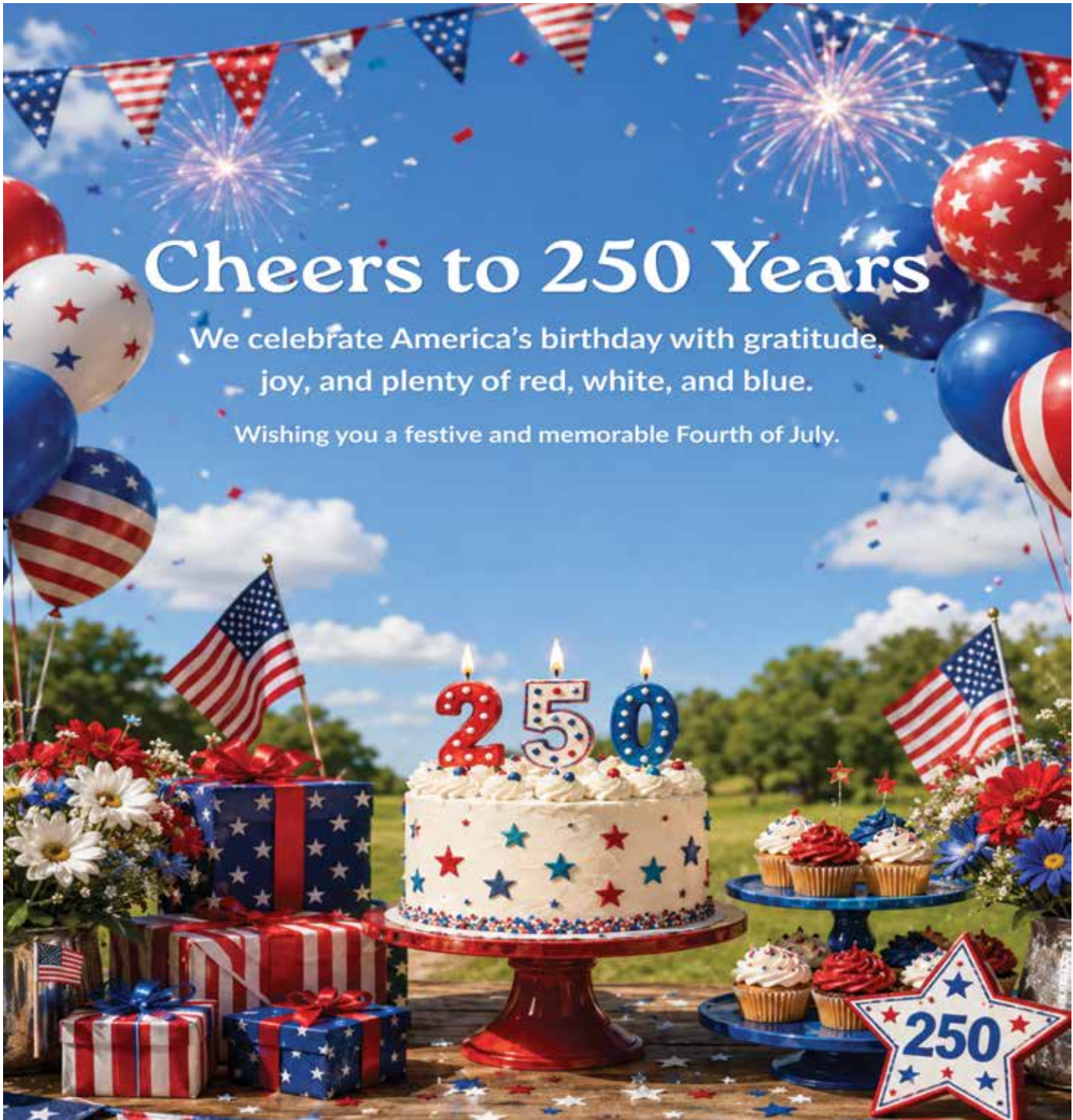


exposure is good. Your foreground objects will generally be silhouetted but you want them not to be completely dark.

If you include people in the shot and you don't want them silhouetted use your flash to light them up.
